Pursuant to the Court's March 18, 2015 Order Vacating Deadlines Pending Settlement (Doc. 58), eBay Inc., Dotcom Retail Limited, and Beautybay.com Limited hereby set forth the status of the settlement between the parties, and request a further suspension of 60 days to complete the settlement terms.

On March 11, 2015, the parties executed a confidential settlement agreement that will, when the terms thereof have been fully completed, resolve this action. The parties have made progress in fulfilling the milestones in the settlement agreement, but require a further sixty (60) days to implement their obligations under the settlement.

There are presently no deadlines in the case, as all deadlines were vacated by the Court's March 18, 2015 Order.

The parties believe that a short continuation of the suspension of this action pending the full implementation of the parties' obligations under the settlement will result in eventual dismissal of this action, thereby avoiding significant burdens on this Court's time and resources, and on the parties' resources. Therefore, the parties jointly move that the Court set a further status update for August 10, 2015.
