1 Plaintiff Synopsys, Inc. (“Synopsys”) and Defendant ATopTech, Inc. (“ATopTech”)
2 (together, “the Parties”), by and through the undersigned counsel, submit this Stipulation and
3 Proposed Order Regarding Pretrial Deadlines.

4 WHEREAS the Parties wish to facilitate the orderly and efficient exchange of pretrial
5 information required by ECF Nos. 174 and 458, the Court’s standing Pretrial Instructions, and
6 Federal Rule of Civil Procedure 26;

7 WHEREAS the Parties’ Joint Pretrial Statement, witness lists, proposed voir dire
8 questions and verdict forms are presently due on January 26, 2016;

9 WHEREAS motions in limine are presently due on January 26, 2016, and oppositions due
10 on February 2, 2016;

11 WHEREAS on January 22, 2016, the Court granted Synopsys’ Motion For Leave To File
12 Supplemental Complaint;

13 WHEREAS on January 22, 2016, the Court ordered that the Parties’ proposed jury
14 instructions be filed on January 29, 2016;

15 WHEREAS the Parties believe they will benefit from a limited extension of the filing date
16 of the Joint Pretrial Statement, witness lists, proposed voir dire questions and verdict forms, and
17 motions in limine;

18 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED by the Parties as
19 follows:

20 1. The Parties’ Joint Pretrial Statement, witness lists, proposed voir dire questions
21 and verdict forms shall be due on January 29, 2016, at 5 p.m.;

22 2. Motions in limine shall be due on January 29, 2016, at 5 p.m., and any oppositions
23 to such motion shall be due on February 4, 2016, at 5 p.m.


