**STIPULATION EXTENDING PAGE LIMIT FOR RESPONSE
IN OPPOSITION TO MOTION TO DISMISS**

3 WHEREAS, Plaintiffs filed the First Amended Class Action Complaint (“Complaint”) in the
4 above-titled action in this Court and served it on Defendant Ford Motor Company on November 12,
5 2013;

6 WHEREAS, the Complaint includes 24 plaintiffs from 15 states collectively stating over 80
7 causes of action;

8 WHEREAS, Ford filed its motion to dismiss under Rule 12(b) on January 13, 2014;

9 WHEREAS, on January 10, 2014, the parties stipulated to an extension of 50 pages for
10 Defendant’s Motion to Dismiss;

11
12 WHEREAS, Local Rule 7-3(a) provides that any opposition brief or memorandum may not
13 exceed 25 pages of text;

14 WHEREAS, on January 22, 2014, this Court granted the stipulation to an extension of 50
15 pages for Defendant’s Motion to Dismiss;

16 WHEREAS, Local Rule 7-11 permits a party to seek miscellaneous administrative relief,
17 including permission “to exceed otherwise applicable page limitations,” pursuant to a stipulation by
18 the parties;

19
20 WHEREAS, Plaintiffs anticipate they will need 50 pages to adequately present their response
21 in opposition to Ford’s Motion to Dismiss in light of the number of pages extended to Defendant;

22 WHEREAS, Ford has stipulated that it will not oppose a request by Plaintiffs to extend the
23 page limit for the brief in support of their opposition to a comparable number of pages;

24 WHEREAS, execution of this stipulation is not a waiver of any claims or defenses Plaintiffs
25 or Defendant may otherwise have;
