15           Whereas, the defendant contends that it is not in position to confer regarding ADR, a  
16 discovery plan, or initial disclosures until a ruling is made on Defendant’s motion.

18           1.       The Initial Case Management Conference will be continued to February 26, <sup>2014</sup>~~2013~~  
19 at 10:00 a.m., in Courtroom A, 15<sup>th</sup> Floor.

20           2.       The last day to meet and confer regarding initial disclosures, file an ADR  
21 Certification, and file either a Stipulation to ADR or Notice of Need for ADR Phone Conference  
22 is extended to a date two weeks after the Court rules on Defendant’s motion, if the motion is  
23 denied.

24           3.       The last day to file a Rule 26(f) Report, complete initial disclosures, and file a  
25 Case Management Statement is February 19, 2014.
