**PARTIES' STIPULATION AND JOINT
 MOTION TO EXTEND TIME TO
 EXCHANGE CLAIM CONSTRUCTIONS
 AND EXTRINSIC EVIDENCE**

20 Plaintiff WhatsApp, Inc. ("WhatsApp") and Defendant Intercarrier Communications, LLC
 21 ("ICC") (collectively "Parties") hereby stipulate and respectfully submit this stipulation and joint
 22 motion to extend the deadline for one date in the current case schedule. In support, the Parties
 23 state the following:

- 24 1. Pursuant to the Court's Case Management and Scheduling Order (D.I. 33), the
 25 Parties are currently scheduled to exchange preliminary claim constructions and extrinsic evidence
 26 on May 5, 2014.
- 27 2. Due to the press of other case and business matters, ICC requested to WhatsApp a

1 brief extension of time for the Parties to exchange their preliminary claim constructions and
2 extrinsic evidence.

3 3. The Parties have conferred and agree to extend the deadline for the exchange to until
4 May 13, 2014.
