ORDER VACATING HEARING

Before the Court is Defendants Chevron U.S.A. Inc., MB Enterprises, Inc., Massoud
Ebrahimi, and Bhagdeep S. Dhaliwal's Motion for Good Faith Settlement Determination. ECF
No. 255. Pursuant to Federal Rule of Civil Procedure 78(b) and Civil Local Rule 7-1(b), the Court
