24 The parties herein hereby stipulate and jointly apply to the Court for relief from
 25 existing deadlines in the above-referenced matter as follows:

26 The parties had agreed to a voluntary settlement conference with Magistrate Judge
 27 Laurel Beeler. The initial settlement conference was originally held on August 5, 2014. A
 28 second settlement conference was held on September 24, 2014. The parties and Magistrate
 Judge Beeler have agreed that further settlement discussions would be productive. It would

1 promote the possibility of settlement and be in the interest of justice if the case management
2 conference, currently set for November 12, 2014, and certain other deadlines, including those
3 relating to defendants' 12(c) motions, were continued until after the parties have had an
4 opportunity to for further settlement discussions.

10 Deposition of defendant Santana completed by December 30, 2014;
11 Filing of joint case management conference statement: January 7, 2015;
12 Case management conference: January 14, 2015 at 10:00 am (or at the same time as
13 the 12(c) hearing;
14 Defendants' 12(c) motions: January 14, 2015 at 1 pm (or at the same time as the
15 CMC).
