WHEREAS, on July 22, 2014, Defendants Wells Fargo & Co., Wells Fargo Advisors, LLC, and Wells Fargo Financial Network, LLC ("Defendants") will file a motion for partial summary judgment pursuant to the parties' Memorandum of Understanding (lodged with the Court on June 19, 2014) and the Court's order dated June 19, 2014 (Dkt. No. 38);

WHEREAS, pursuant to the Court's Standing Order dated April 18, 2014, the parties have agreed upon a joint statement of undisputed facts ("SUF");

WHEREAS, some of the facts contained in the SUF will be supported by evidence submitted by Defendants in connection with Defendants' opening brief and some by evidence submitted by Plaintiffs in connection with Plaintiff's opposition brief;

WHEREAS, Plaintiffs will not be in a position to finalize their evidence by July 22, 2014 but will update the SUF with paragraph and exhibit references to Plaintiffs' evidence at the time Plaintiffs' opposition brief is filed on August 5, 2014;

NOW, THEREFORE, the parties stipulate as follows:

- 1. Each fact contained in the SUF is undisputed and is supported by evidence in the parties' possession.
 - 2. Defendants will file the SUF and their supporting evidence on July 22,
- 3. Plaintiffs shall then re-file the SUF, along with their supporting evidence on August 5, 2014, and shall support any and all facts in the SUF that are not supported by evidence submitted by Defendants. No fact within the SUF shall go unsupported.
- 4. The re-filed SUF shall be the same in form and in content—with the sole exception that Plaintiffs will update the SUF with paragraph and exhibit references to Plaintiffs' evidence—and shall serve to supplant the SUF filed by Defendants on July 22, 2014. No augmentations, deletions, or other modifications to the substance of the SUF shall be made at the time of the re-filing of the SUF on August 5, 2014.
