**STIPULATION RE: CASE  
MANAGEMENT, DOCUMENT  
PRODUCTION AND MEDIATION**

The further case management conference  
is continued to 3/20/15 @ 3 p.m.

TO THIS COURT AND ALL PARTIES THROUGH THEIR ATTORNEYS OF RECORD:

The parties have stipulated to the following in regard to the Case Management Schedule,  
document production, and Mediation:

1. The parties have agreed to go to mediation, which is set for March 18, 2015. To allow  
the parties to be prepared for mediation and only for that purpose, Defendants agree to  
produce the time and payroll records from November 12, 2009 (four years prior to the

1 filing of the Complaint in this Action) to November 12, 2013 for each member of the  
2 Proposed Class, including Plaintiff ALEXANDER YALUNG. Prior to class  
3 certification, the records of the non-class representative employees that have not opted  
4 into the case are only to be used for mediation purposes and not for class certification  
5 purposes. A true and correct copy of the Proposed Class List is attached hereto as  
6 Exhibit 1. The list has been redacted to protect the information of putative class  
7 members.

- 9 2. Plaintiffs' deadline to file their Motion for Class Certification was January 9, 2015.  
10 Subsequently, Plaintiffs requested that Defendants agree to continue the deadline to file  
11 the Motion for Class Certification. Defendants advised plaintiffs that they are unsure  
12 whether the Court's calendaring could be altered through a stipulation. However, if the  
13 Court allows it and to give the parties time to engage in mediation, the parties agree to  
14 continue Plaintiffs' deadline to file a Motion for Class Certification to April 20, 2015.
- 15 3. The parties also request that the CMC currently scheduled for March 13, 2015 be  
16 continued for one week so that the parties may engage in mediation before reporting back  
17 to this Court.
