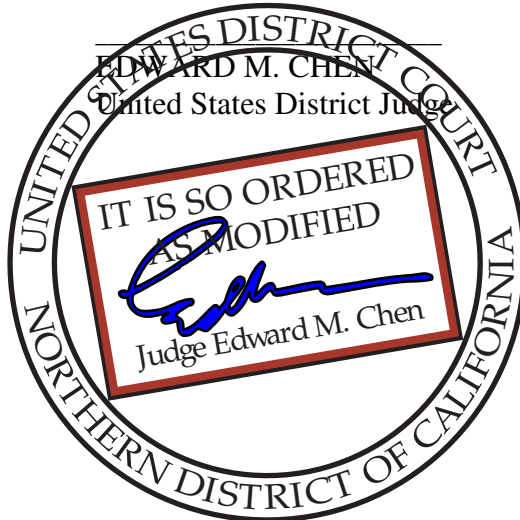
2 COME NOW Kathleen Dunn, Patrick Campbell, Fred Hickson, and Karen Hobson
