12 1. To Warden Ronald Rackley of the California Health Care Facility At Stockton;

14 2014 in circumstances that will allow him to make confidential calls to his

21 telephonically attending the settlement conference, and said e-mail shall
22 describe with particularity any information useful or necessary to ensure the

1 c.) No recording of these phone calls will be allowed, and should the Warden in his
2 discretion believe Mr. Herriot needs to be monitored in any fashion during this
3 time, the Warden is requested to do so in a manner which will best insure
4 confidentiality of the attorney-client communications that are anticipated to
5 occur between Mr. Herriot and Mr. Powell, while accomplishing any goals of
6 the Warden for security of Mr. Herriot or the California Health Care Facility At
7 Stockton.

10 through the ECF system, to Erin Takehara at the e-mail address provided above.

11 e.) If, upon receipt of this Order or at any time prior to the scheduled Settlement
12 Conference the Warden or Ms. Takehara believe there is any information of

14 any aspect of this Order and the ability to comply with it, an e-mail describing
15 the information and any issues related thereto shall be sent as early as is feasible,
