**NOTICE RE CIVIL LOCAL
RULE 3-9**

19 In January 2014, plaintiff Adobe Systems Inc. filed a complaint alleging copyright and
20 trademark infringement. After experiencing some service issues, the parties now represent that
21 “[a]ll named parties have been served” (Dkt. No. 28).

22 On May 20, the parties represented that “Defendants have retained settlement counsel in
23 an attempt to resolve this matter at this early stage” (Dkt. No. 25). In their joint case
24 management conference statement, dated June 12, the parties stated that they anticipate filing
25 dispositive motions (Dkt. No. 28).

26 No attorney has appeared on behalf of defendant Accoladian Resources LLC. The joint
27 statement bears the signature of “Vern Cameron, Defendant, *in pro se*” for defendant Accoladian
28 Resources LLC. He also represents himself *pro se*. The proof of service states that a “*Courtesy*

1 *Copy*” was sent to “Tiffany J. Brown, Esq.,” located in Miramar, Florida. Attorney Brown has
2 not noticed an appearance or filed a *pro hac vice* application in this action.

3 Defendants should be aware that Civil Local Rule 3-9 states:

4 (a) Natural Person Appearing Pro Se. *Any party representing him*
5 *or herself without an attorney must appear personally* and may not
6 delegate that duty to any other person who is not a member of the
7 bar of this Court. A person representing him or herself without an
attorney is bound by the Federal Rules, as well as by all applicable
local rules. Sanctions (including default or dismissal) may be
imposed for failure to comply with local rules.


8 (b) Corporation or Other Entity. *A corporation, unincorporated*
9 *association, partnership or other such entity may appear only*
through a member of the bar of this Court.

10 Defendant Accoladian Resources LLC may appear only through a member of the bar of this
11 Court. Individual defendant Vern Cameron may appear *pro se*.

12 Moreover, please be aware that the undersigned judge’s courtroom is not configured for
13 telephonic appearances. This means that all parties must appear in person at the scheduled time.
14 A May 21 order granted a three-week continuance of the initial case management conference to
15 **JUNE 19, 2014, AT 11:00 A.M.** Please report to Courtroom 8, on the 19th Floor, Phillip Burton
16 Federal Building, 450 Golden Gate Avenue, San Francisco, CA 94102. The order stated: “there
17 will be no further continuances” (Dkt. No. 26).

18 Plaintiff shall promptly serve defendants with a copy of this notice.
