| 2 | and Defendants VUDU, Inc. ("VUDU") and Digital Entertainment Content Ecosystem |
| 3 | (DECE) LLC ("DECE") hereby jointly stipulate and agree as follows: |
| 4 | Grecia's initial complaint against VUDU and DECE was filed in Case No. 3:14-cv- |
| 5 | 01220-EMC (the "VUDU/DECE Litigation"). The Court granted VUDU and DECE's |
| 6 | motions to dismiss the initial complaint on August 29, 2014 (Dkt. 60). |
| 7 | Grecia's first amended complaint against VUDU and DECE was filed on September |
| 8 | 5, 2014 in Grecia v. Apple Inc., Case No. 3:14-cv-775-EMC (Dkt. 135) (the "Apple Litigation"). |
| 9 | Grecia, VUDU, and DECE now stipulate that (1) Grecia will file the second |
| 10 | amended complaint attached as Exhibit A to this Stipulation by October 3, 2014, which shall |
| 11 | supersede the first amended complaint filed on September 5, 2014, (2) VUDU and DECE |
| 12 | need not respond to the first amended complaint, and (3) VUDU and DECE shall have until |
| 13 | October 17, 2014 to answer or otherwise respond to the second amended complaint. |
| 14 | VUDU's and DECE's consent to Plaintiff filing the second amended complaint attached as |
| 15 | Exhibit A shall not be construed as an admission or waiver of any argument or defenses |
| 16 | relating to the sufficiency of Plaintiff's second amended complaint. VUDU and DECE |
| 17 | reserve all rights with respect to the second amended complaint, including that it continues |
| 18 | to fail to state a claim. |
| 19 | The only pending Court-ordered deadlines in this case are for the December 2014 |
| 20 | case management statement and case management conference. These deadlines are not |
| 21 | affected by this stipulation. |
| 22 | IT IS SO STIPULATED. |
