 25 set forth in said joint stipulation, this Court orders:

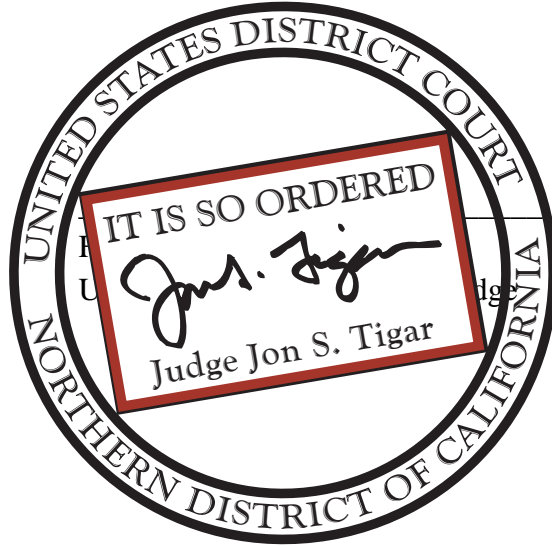
26 The hearing date on Twin City’s Motion to Dismiss Plaintiffs’ Complaint is continued from
