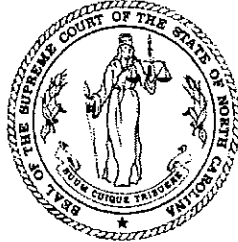
IT IS HEREBY ORDERED THAT the application of John P. Higgins is granted,
