18 IT IS HEREBY STIPULATED by and between Petitioner the United States of America

25 7-4(b), and 7-11) by September 25, 2014th.

26 3. Respondent reserves his right to seek permission to file a Sur-Reply (consistent
27 with Civil Local Rules 3-4(c)(2), 7-3(a), 7-3(d), and 7-4(b)).

28 4. The United States may re-notice the hearing on the Order to Show Cause for an

1 available date on the Court's calendar which is not less than 21 days from the date upon which
2 its Reply is filed. Should Respondent file a Sur-Reply, the United States shall re-notice the
3 hearing on the Order to Show Cause for an available date on the Court's calendar which is not
4 less than 21 days from the date upon which the Sur-Reply is filed.

5 5. Respondent reserves his right to seek a continuance of any hearing date selected
6 by the United States (consistent with Civil Local Rule 7-7(b)), to the extent such date is not
7 acceptable to Respondent.

8 WHEREFORE the United States and Respondent hereby respectfully request that the
9 Court issue an Order adopting the foregoing schedule, and grant such other and further relief as
10 is just and proper.
