18 In this action, Defendant ZURICH AMERICAN INSURANCE COMPANY brought a
19 Motion for Summary Judgment in Case No. 3:14-cv-02043-SC against Plaintiff RANDY
20 STEVENS AND ELISSA STEVENS. The motion was taken under submission by the Honorable
21 Samuel Conti without a hearing as prescribed by Northern District of California Local Rule 7-1(b).

22 Whereas the evidence and issues presented having been fully considered and a decision
23 having been duly rendered, and whereas on September 9, 2015, the Court granted Defendant
24 ZURICH AMERICAN INSURANCE COMPANY's Motion for Summary Judgment on the
25 Complaint filed by Plaintiffs RANDY STEVENS AND ELISSA STEVENS. Attached hereto as
26 Exhibit A is a copy of this Court's Order Granting Zurich American Insurance Company's Motion
27 for Summary Judgment.

28 Whereas the Court's Order would entitle Defendant ZURICH AMERICAN INSURANCE

1 COMPANY to a Judgment of Dismissal with prejudice in its favor on all causes of action against it
2 in Plaintiffs' Complaint.

3 Whereas Defendant ZURICH AMERICAN INSURANCE COMPANY is entitled to an
4 award of costs pursuant to Federal Rule of Civil Procedure § 54(d).

5 IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT Plaintiffs RANDY
6 STEVENS AND ELISSA STEVENS take nothing, that the action be dismissed on the merits and
7 that a Judgment of Dismissal with prejudice on the Complaint brought by Plaintiffs RANDY
8 STEVENS AND ELISSA STEVENS in the above-entitled action is entered in favor of Defendant
9 ZURICH AMERICAN INSURANCE COMPANY as to all causes of action stated against it and
10 that Defendant ZURICH AMERICAN INSURANCE COMPANY shall recover its costs.
