6 time to, and including, September 8, 2014, to answer or otherwise respond to Plaintiff's complaint;


7 WHEREAS, this is the first extension of Defendants' time to answer or otherwise respond

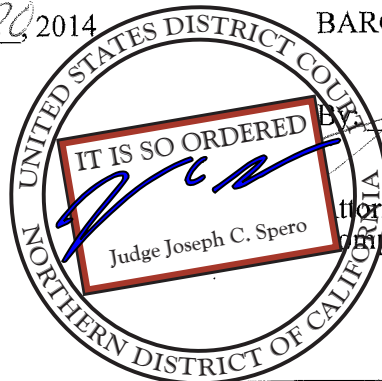
