24 Plaintiff Ronpak, Inc. and Defendant Electronics for Imaging, Inc. (collectively referred to  
25 herein as “the Parties”) hereby stipulate and agree as follows:

26 The Case Management Conference in this case is initially scheduled for December 17, 2014  
27 at 2:00 p.m. The parties are currently making progress in their settlement discussions and request

1 that the Court continue the Case Management Conference so that they may complete their  
2 negotiations.

3 The parties have made one prior request to modify the Court's calendar in this matter, which  
4 was to continue the date for the hearing on Defendant's Motion to Dismiss. They made that request  
5 was made for same reason as this one – to permit the conclusion of settlement discussions. The  
6 Court granted that request in its December 2, 2014 Order, moving the hearing from December 4,  
7 2017 to January 8, 2015. *See*, DE 25.

8 The parties do not believe that re-setting the Case Management Conference will have a  
9 material effect on the timing of this action. Moreover, the likelihood that the parties can resolve  
10 their dispute at this early stage merits the delay caused by the requested continuance.

11 THEREFORE, the parties jointly request that the Court reset the Case Management  
12 Conference thirty days (30) from December 17, 2014 to **January 21, 2015** or as soon as it can be  
13 heard by this Court, with the parties' Joint Case Management Conference Statement due 10 court  
14 days prior.
