 ARBITRATION PROCEEDINGS**

1 THE PARTIES, THROUGH COUNSEL, STIPULATE TO THE FOLLOWING:

2 Whereas, Plaintiff Victoria Comfort brought this action, seeking damages and other relief
3 against Defendants JT Foxx, World Success Company LLC, and The Coaching Organization,
4 LLC;

5 Whereas, Defendants filed a Petition to Compel Arbitration on November 20, 2014,
6 which is currently pending before the Court;

7 Whereas, the parties have agreed that the claims in this case will be arbitrated in San
8 Francisco, California, before AAA Arbitration;

9 Whereas, the parties believe it would be economically efficient and promote justice for
10 this action to be stayed pending the completion of the arbitration;

11 Now, therefore it is agreed that:

- 12 1. This action shall be stayed in its entirety;
- 13 2. All dates currently scheduled in this case shall be vacated;
- 14 3. Defendants' pending Petition to Compel Arbitration shall be removed from the
15 Court's calendar, without prejudice to re-filing or re-noticing if circumstances warrant;
