22	The parties need not submit written materials to the ADR Unit for the telephone conference.	
23	In preparation for the telephone conference, Plaintiff shall do the following:	
24	(1) Review relevant loan documents and investigate the claims

(2) If Plaintiff is seeking a loan modification to resolve all or some of the claims, Plaintiff shall prepare a current, accurate financial statement and gather all of the information and documents customarily needed to support a loan modification request. Further, Plaintiff shall immediately notify Defendants(counsel of the request for a loan modification)

Provide counsel for Defendants with information necessary (3) 1 to evaluate the prospects for loan modification, in the form of a financial statement, worksheet or application customarily used by 2 financial institutions. 3 In preparation for the telephone conference, counsel for Defendants shall do the following. 4 If Defendants are unable or unwilling to do a loan (1)modification after receiving notice of Plaintiff(s request, counsel for 5 Defendants shall promptly notify Plaintiff to that effect. 6 Arrange for a representative of each Defendant with full (2)settlement authority to participate in the telephone conference. 7 The ADR Unit will notify the parties of the date and time that the telephone conference 8 will be held.
