10 The parties respectfully submit this Stipulation to the Court pursuant to Local Rule 6-1(a).

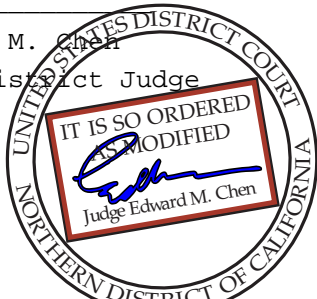
