17 In the above entitled action, the defendant RUBEN PACHECO aka RUBEN R.
18 PACHECO aka RUBEN RICHARD PACHECO having been duly served with the Summons
19 and a copy of the Complaint in the action, and the defendant having failed to appear,
20 answer, plead, or otherwise defend in the action within the time allowed by law, or at all,
21 and default having been duly entered; and it further appearing that plaintiff's claim against
22 the defendant is for a sum certain and for interest which can by computation be made
23 certain and for costs; and it further appearing that a declaration on behalf of the plaintiff
24 required by Rule 55 has been filed, setting forth the amounts due plaintiff from said
25 defendant in accordance with the prayer of the Complaint, and also setting forth that
26 defendant is not an infant or incompetent person or in the military service of the United
27 States within the meaning of the Service Members Civil Relief Act [50 U.S.C. Appx. §§ 501
28 *et. seq.*] (formerly the Soldiers' and Sailor's Civil Relief Act of 1940), or otherwise entitled to

1 the benefits of said Act, and praying that Judgment be entered herein.

2 NOW, THEREFORE, by virtue of the law and by reason of the premises aforesaid,

3 IT IS ADJUDGED that the United States of America, plaintiff, do have and recover of
4 and from the defendant, RUBEN PACHECO aka RUBEN R. PACHECO aka RUBEN
5 RICHARD PACHECO, the sum of \$7,432.79 as principal, interest, attorney fees, and costs,
6 plus interest in the amount of \$0.28 per day from February 12, 2015, to the date of entry of
7 the judgment, plus post judgment interest thereafter at the current legal rate per annum,
8 pursuant to the provisions of 28 USC Sec. 1961(a) which will be compounded annually
