**ORDER RE MEET
AND CONFER RE
MOTION TO COMPEL**

21 In this miscellaneous action, on May 23, defendants filed a motion to compel
22 third-party Paul Financial, LLC, to produce documents responsive to a subpoena for an action
23 pending in the District of Connecticut. *Federal Housing Finance Agency v. Royal Bank of*
24 *Scotland Group PLC, et al.*, No. 3:11-cv-01383-AWT (D. Conn. Sept. 2, 2011) (Judge Alvin
25 Thompson). The motion is noticed for a hearing on July 10. Fact discovery closes on July 25,
26 2014.

1 On June 18, counsel for Paul Financial, Weintraub Tobin Chediak Coleman Grodin
2 Law Corporation, filed a statement of non-opposition (Dkt. Nos. 9, 10). Counsel represented:

3 It is expected that full compliance with the subject subpoena will
4 be accomplished by the 27th of June, mootng the issues raised in
the Motion to Compel.

5 By **NOON ON JULY 3, 2014**, lead counsel for Paul Financial and lead counsel for
6 defendants shall file a statement certifying that they have met and conferred in person in this
7 district in a good faith effort to resolve all outstanding discovery issues. The statement shall
8 state where and for how long counsel met and conferred. If counsel have resolved their
9 discovery dispute, the joint statement shall include a joint stipulation and proposed order
10 resolving the pending motion to compel.
