**STIPULATION AND [PROPOSED] ORDER
 RE: ONE-DAY BENCH TRIAL**

1 **STIPULATION**

2 Plaintiffs Hakan Yucesoy, Abdi Mahammed, Mokhtar Talha, Brian Morris, and Pedro
3 Sanchez (“Plaintiffs”) and Defendants Uber Technologies, Inc., Ryan Graves, and Travis Kalanick
4 (“Defendants”) (collectively, the “Parties”), by and through their respective counsel of record, hereby
5 stipulate as follows:

6 WHEREAS, on May 22, 2015, Defendants filed a motion to compel arbitration, *see* Docket
7 No. 62;

8 WHEREAS, on June 23, 2015, Plaintiffs filed their opposition to Defendants’ motion to
9 compel arbitration, *see* Docket No. 72;

10 WHEREAS, on July 8, 2015, Defendants filed their reply in support of their motion to compel
11 arbitration, *see* Docket No. 80;

12 WHEREAS the hearing on Defendants’ motion to compel arbitration took place on August 6,
13 2015;

14 WHEREAS, the Court ordered the Parties to meet and confer and to submit to the Court by
15 August 13, 2015 a proposed scheduling order for a bench trial on the issue of whether Plaintiff
16 Yucesoy formed a contract with Uber, *see* Docket No. 95;

17 WHEREAS, the Court has scheduled a further case management conference for November
18 19, 2015, *see id.*;

19 WHEREAS the Parties have conferred and agreed to propose November 19, 2015, for the
20 bench trial on the issue of whether Plaintiff Yucesoy formed a contract with Uber, which date would
21 be convenient for the Court and the Parties given that a further case management conference in this
22 matter has already been scheduled for that day;

23 WHEREAS the Parties have conferred and further agreed that the deposition of Mr. Yucesoy
24 will occur on November 17, 2015, in San Francisco, California, and that the deposition transcript will
25 be in final form by November 19, 2015, for use at trial;
