1 Pursuant to the United States District Court, Northern District of California Local
2 Rules, Rule 6-1(a), the parties stipulate as follows.

3 WHEREAS, the Summons and Complaint in this action were served on defendants on
4 January 27, 2015, such that defendants' responses are due, pursuant to Fed. R. Civ. P. 12, on
5 February 17, 2015;

6 WHEREAS, defendants previously requested, and plaintiff previously agreed to a 30-
7 day extension, and another 14-day extension of defendants' time to respond to the Complaint
8 (*see* Dkt. Nos. 10, 17);

9 WHEREAS, defendants have again requested, and plaintiff has again agreed to an
10 additional 21-day extension for the reasons set forth in the Declaration of Jack Fitzgerald;

11 NOW, THEREFORE, IT IS STIPULATED BY AND BETWEEN THE PARTIES:

12 Upon the Court's Order, Defendants' deadline for responding to the Complaint shall
13 be extended to on or before April 23, 2015. Further, the Initial Case Management Conference
14 currently scheduled for April 21, 2015 (*see* Dkt. No. 15) shall be vacated, and will be
15 rescheduled by the Court after defendants respond to the Complaint.
