1	(3) Provide counsel for Defendants with information necessary to evaluate the	
2	prospects for loan modification, in the form of a financial statement, worksheet or application customarily used by financial institutions.	
3	In preparation for the telephone conference, counsel for Defendants shall do the

5	(1) If Defendants are unable or unwilling to do a loan modification after	
6 7	receiving notice of Plaintiff's request, counsel for Defendants shall promptly notify Plaintiff to that effect.	
8	(2) Arrange for a representative of each Defendant with full settlement authority to participate in the telephone conference.

10	The ADR Unit will notify the parties of the date and time the telephone conference will	
11	be held. After the telephone conference, the ADR Unit will advise the Court of its
