21 IT IS HEREBY STIPULATED by and between plaintiff ROBERT FOWLER
 22 (FOWLER) and Defendants CITY OF SANTA ROSA and DAN JONES (collectively,
 23 CITY), through their respective counsel of record, as follows:

- 24 1. Counsel of record Fritsch and Sax met and conferred, and agree that the
 25 acquisition of additional evidence will facilitate the Settlement Conference. To wit,
 26 CITY will obtain the testimony of plaintiff Fowler, and percipient witnesses Casey
 27 Fowler and Angela Chamberlin. FOWLER will obtain the testimony of Officers JONES
 28 and Mann.

1 2. Counsel estimate that this work can be accomplished and evaluated in six
2 weeks;

3 3. This matter is set for a mandatory Settlement Conference before Judge
4 Westmore on September 18, 2015;

5 4. Trial is set for June 13, 2016. The court has not set a due date for
6 completion of the MSC;

7 5. Counsel for CITY and plaintiff FOWLER agree that in the interests of
8 judicial economy and justice, all would benefit from a continuance of the Settlement
9 Conference to a continued Conference date on or after October 25, 2015 to be
10 determined by the court.
