1 Plaintiff Rajina Schlitt (“Schlitt”), and Defendant Abercrombie & Fitch
2 Stores, Inc. (“Abercrombie”), through the undersigned counsel do hereby stipulate
3 to the following:

4 1. Abercrombie filed its Motion for Summary Judgment (“Motion”) on
5 February 29, 2016, with a noticed hearing date of May 4, 2016.

6 2. Schlitt shall have until April 6, 2016, inclusive, to file her Opposition
7 to Abercrombie’s Motion.


