27 WHEREAS plaintiff filed her Fifth Amended Complaint on July 22, 2015, which
 28 contains five causes of action; and

WHEREAS on August 5, 2015, defendants filed a Motion to Dismiss the Fourth Cause of
 action brought solely against defendant Ed Buonaccorsi and the Fifth Cause of Action against
 defendant Paula Shimizu; and

1 WHEREAS the parties have met and conferred regarding the Motion to Dismiss, the
2 parties hereby STIPULATE to the following:

- 3 1. That the Fourth Cause of Action (Intentional Infliction of Emotional Distress)
4 brought solely against Ed Buonaccorsi be dismissed without prejudice.
- 5 2. That the Fifth Cause of Action (Interference with Prospective Economic Advantage
6 and Violation of Govt. Code §19680(c) against defendant Paula Shimizu be dismissed
7 without prejudice.
- 8 3. That the hearing on defendants' Motion to Dismiss scheduled for September 30, 2015
9 at 2:00 p.m. is vacated.
- 10 4. That the remaining defendant(s) will file an answer to the Fifth Amended Complaint
11 within 10 days of entry of an order dismissing the Fourth Cause of Action and the
12 Fifth Cause of Action of plaintiff's Fifth Amended Complaint.
- 13 5. Each party shall bear its own fees and costs.
