18 **I. STIPULATION**

19 On July 21, 2015, the Court held a Case Management Conference and discussed with the  
 20 parties a case management schedule. Pursuant to the Court's instructions, counsel for the parties  
 21 have further conferred over case deadlines and hereby stipulate and agree to the following case  
 22 management schedule:


- 23 1. The deadline to amend the pleadings is August 14, 2015.
- 24 2. The deadline to complete ADR/mediation is October 6, 2015.
- 25 3. The fact discovery cutoff is March 21, 2016.
- 26 4. The deadline to disclose expert witness reports is April 29, 2016.
- 27 5. The deadline to disclose rebuttal expert witness reports is May 20, 2016.

- 1 6. The expert discovery cutoff is June 24, 2016.
- 2 7. The deadline for the hearing on any dispositive motions is May 26, 2016, 2:00 p.m.
- 3 8. The pretrial conference is July 26, 2016, 3:00 p.m.
- 4 9. A five-day jury trial is scheduled for August 8, 2016, 8:30 a.m.

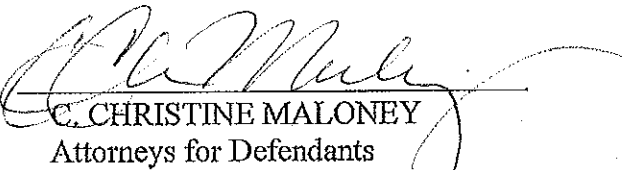

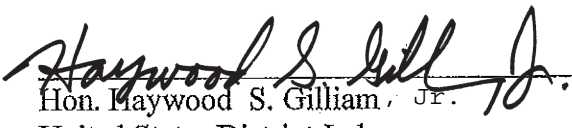
