NOTICE OF SETTLEMENT AND
[PROPOSED] ORDER CONTINUING
CASE MANAGEMENT CONFERENCE

1 The Parties hereby advise the Court that they reached an agreement this morning to settle this
2 action on an individual basis, contingent on final approval of a classwide settlement in *Barron, et al.*
3 *v. Snyder's-Lance, Inc.*, Case No. 0:13-cv-62496-JAL (United States District Court for the Southern
4 District of Florida) ("*Barron*"). The *Barron* parties intend to submit a final settlement agreement for
5 preliminary approval no later than September 8, 2015, and *Barron* has been stayed until that time.
6 The Parties intend to seek a stay of this case pending the *Barron* final approval, including the time
7 for appeal(s) from such approval, and to file for such a stay promptly upon the filing of the *Barron*
8 preliminary approval motion.

9 Accordingly, the Parties request that the August 6, 2015 Case Management Conference be

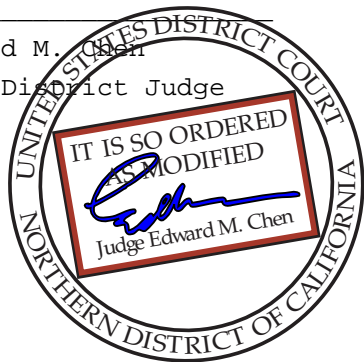
