**STIPULATION AND AGREEMENT OF  
 COMPROMISE AND SETTLEMENT AND  
 19 ~~PROPOSED~~ ORDER**

20  
 21 IT IS HEREBY STIPULATED by and between the Parties, after full and open discussion,  
 22 that this action be settled and compromised on the following terms:

23 WHEREAS, Plaintiff filed the above-captioned action under Title VII of the Civil  
 24 Rights Act of 1964, 42 U.S.C. §2000e-16, as amended and the Rehabilitation Act of 1973;

25 WHEREAS, Plaintiff and Defendant wish to avoid any further litigation and  
 26 controversy and to settle and compromise fully any and all claims and issues that have been raised,  
 27 or could have been raised, arising out of Plaintiff's employment with Defendant, which have  
 28 transpired prior to the execution of this Agreement;

1 NOW, THEREFORE, in consideration of the mutual promises contained in this Agreement,  
2 and other good and valuable consideration, receipt of which is hereby acknowledged, the Parties  
3 agree as follows:

4 1. **Settlement Amount.** In full and final settlement of all claims in connection with  
5 the above-captioned action, Defendant shall pay Plaintiff a total sum of seventy five thousand  
6 (\$75,000) dollars (“Settlement Amount”). There shall be no withholding from this amount. Plaintiff  
7 understands that this payment will be reported to the Internal Revenue Service (“IRS”), and that any  
8 questions as to the tax liability, if any, as a result of this payment is a matter solely between Plaintiff  
9 and the IRS. The check will be made payable to Kavita Lalwani, and will be mailed to Plaintiff at  
10 the following address: 642 Dowling Boulevard, San Leandro, California 94577. Plaintiff has been  
11 informed that payment of the Settlement Amount may take up to sixty (60) days from the date that  
12 the Court “so orders” this Agreement to process.

13 2. **Release.** In consideration of the payment of the Settlement Amount and the other  
14 terms set forth in this Stipulation and Agreement, Plaintiff hereby releases and forever discharges  
15 Defendant, Department of Health and Human Services, and any and all of their past and present  
16 officials, agents, employees, attorneys, insurers, their successors and assigns, from any and all  
17 obligations, damages, liabilities, actions, causes of actions, claims and demands of any kind and  
18 nature whatsoever, including claims arising under the Age Discrimination in Employment Act, 29  
19 U.S.C. § 633a, whether suspected or unsuspected, at law or in equity, known or unknown, or omitted  
20 prior to the date she executes this Agreement, which arise from or relate to her employment with the  
21 Department of Health and Human Services.

22 3. **Each Party to Bear Their Own Attorney’s Fees & Costs:** The Parties shall be  
23 responsible for the payment of their own costs, attorney’s fees and all other expenses each has  
24 incurred at all stages of litigation, including, but not limited to, the processing of Plaintiff’s  
25 administrative and district court complaints in connection with the above-captioned action, and any  
26 other Equal Employment Opportunity administrative proceedings which are currently pending.

1           4. **Dismissal**. In consideration of the payment of the Settlement Amount and the  
2 other terms of this Agreement, Plaintiff agrees that she will, within seven (7) days of this  
3 Agreement, execute a Stipulation of Dismissal, which stipulation shall dismiss, with prejudice, all  
4 claims asserted in this Action or any claims that could have been asserted in this Action. The fully  
5 executed Stipulation of Dismissal will be held by counsel for Defendant and will be filed with the  
6 Court upon receipt by Plaintiff of the Settlement Amount.

7           5. **Waiver of California Civil Code § 1542**. The provisions of California Civil  
8 Code Section 1542 are set forth below:

9                           “A general release does not extend to claims which the creditor does not know  
10                           or suspect to exist in his or her favor at the time of executing the release,  
11                           which if known by him or her must have materially affected his or her  
12                           settlement with the debtor.”

13 Plaintiff has been apprised of the statutory language of Civil Code Section 1542 by her attorneys,  
14 and fully understanding the same, nevertheless elects to waive the benefits of any and all rights she  
15 may have pursuant to the provision of that statute and any similar provision of federal law. Plaintiff  
16 understands that, if the facts concerning Plaintiff's claims and the liability of the government for  
17 damages pertaining thereto are found hereinafter to be other than or different from the facts now  
18 believed by them to be true, this Agreement shall be and remain effective notwithstanding such  
19 material difference.

20           6. **Agreement as a Complete Defense**. This Agreement may be pleaded as a full  
21 and complete defense to any subsequent action or other proceeding involving any person or party  
22 which arises out of the claims released and discharged by the Agreement.

23           7. **No Admission of Liability**. This is a compromise settlement of Plaintiff's  
24 disputed claims and demands, which settlement does not constitute an admission of liability or fault  
25 on the part of the Defendant, the Department of Health and Human Services, or any of their past and  
26 present officials, agents, employees, attorneys, or insurers on account of the events described in  
27 Plaintiff's complaints in these actions.

1           8. **Tax Liability**. If any withholding or income tax liability is imposed upon Plaintiff  
2 based on payment of the settlement sum received herein, Plaintiff shall be solely responsible for  
3 paying any such determined liability from any government agency thereof.

4           9. **Construction**. Each Party hereby stipulates that it has been represented by and  
5 has relied upon independent counsel in the negotiations for the preparation of this Agreement, that it  
6 has had the contents of the Agreement fully explained to it by such counsel, and is fully aware of and  
7 understands all of the terms of the Agreement and the legal consequences thereof. For purposes of  
8 construction, this Agreement shall be deemed to have been drafted by all Parties to this Agreement  
9 and shall not, therefore, be construed against any Party for that reason in any subsequent dispute.

10           10. **Severability**. If any provision of this Agreement shall be found invalid, illegal,  
11 or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not in  
12 any way be affected or impaired thereby.

13           11. **Integration**. This instrument shall constitute the entire Agreement between the  
14 Parties and supersedes any prior agreements, representations, warranties, statements, promises and  
15 understandings, whether oral or written, with respect to the specific subject matter hereof. It is  
16 expressly understood and agreed that the Agreement has been freely and voluntarily entered into by  
17 the Parties hereto with the advice of counsel, who have explained the legal effect of this Agreement.  
18 The Parties further acknowledge that no warranties or representations have been made on any  
19 subject other than as set forth in this Agreement. This Agreement may not be altered, modified or  
20 otherwise changed in any respect except by writing, duly executed by all of the Parties or their  
21 authorized representatives.

22           12. **Authority**. The signatories to this Agreement have actual authority to bind the  
23 Parties.

24           13. **Knowing and Voluntary Waiver of Remedies Under Age Discrimination in**  
25 **Employment Act**. Plaintiff acknowledges that she has up to twenty-one (21) calendar days from the  
26 date she receives this Agreement to review and consider this Agreement, discuss it with an attorney  
27 of her choice, and decide to sign it or not sign it, although she may accept or return it to Defendant's  
28 counsel at any time within those twenty-one (21) days. Plaintiff has been advised to consult her

1 attorney about the Agreement. Once Plaintiff signs and dates this Agreement, she will have seven  
2 (7) days in which to revoke her acceptance. To revoke, Plaintiff must send a written statement of  
3 revocation, which should be mailed and faxed to:




