16 and dates set forth in the operative Scheduling Order issued on May
17 13, 2016 (Dkt. No. 69) shall remain in place.

19 No dates or deadlines set forth in the operative Scheduling Order issued on
20 May 13, 2016 (Dkt. No. 69) shall be altered or otherwise affected by this Order.
