1 On October 25, 2017, the parties in the above-captioned matter filed a stipulation and
2 proposed order to vacate the November 1, 2017 Final Pretrial Conference and November 13,
3 2017 trial date, as the parties have reached an enforceable settlement that will dispose of the
4 entirety of the action. The Court finds that good cause exists to vacate the Final Pretrial
5 Conference and the trial date, and orders as follows:

- 6 1. The November 1, 2017 Final Pretrial Conference is vacated;
- 7 2. The November 13, 2017 trial date is vacated;
- 8 3. A compliance hearing shall be held on March 1, 2018, at 8:00 a.m., in
9 Courtroom 8, 19th Floor, 450 Golden Gate Avenue, San Francisco, California. Five (5) business
10 days prior to the date of the compliance hearing, the parties shall file either (a) a stipulated Order
11 to dismiss the above-captioned action, following the execution of a stipulation and memorandum
12 memorializing the settlement; or (b) a one-page **JOINT STATEMENT** setting forth an
13 explanation regarding the failure to comply. If compliance is complete, the parties need not
14 appear and the compliance hearing will be taken off calendar.
