**STIPULATION FOR VOLUNTARY
REMAND PURSUANT TO
SENTENCE FOUR OF 42 U.S.C.
§ 405(g) AND ENTRY OF JUDGMENT**

23 IT IS HEREBY STIPULATED by the parties, through their undersigned attorneys, and with the
24 approval of the Court, that Carolyn W. Colvin, Acting Commissioner of Social Security (Defendant or
25 the Commissioner) has agreed to voluntarily remand this case for further administrative proceedings,
26 pursuant to sentence four of 42 U.S.C. section 405(g). On remand, the Appeals Council will remand the
27 case to an administrative law judge (ALJ) for a new hearing and decision. The Appeals Council will
28 instruct the ALJ to reevaluate the medical evidence, including, but not limited to, all medical-source
opinion evidence concerning physical and mental impairments, and explain the weight given to the
opinion evidence consistent with 20 C.F.R. section 404.1527 and Social Security Rulings

1 96-2p and 96-5p. The parties further request that the Clerk of the Court be directed to enter a final
2 judgment in favor of Plaintiff, and against Defendant, reversing the Commissioner's final decision
