16 In the above entitled action, the defendant HELI MASHRIQUE aka HELI H.
 17 MASHRIQUE having been duly served with the Summons and a copy of the Complaint in
 18 the action, and the defendant having failed to appear, answer, plead, or otherwise defend
 19 in the action within the time allowed by law, or at all, and default having been duly entered;
 20 and it further appearing that plaintiff's claim against the defendant is for a sum certain and
 21 for interest which can by computation be made certain and for costs; and it further
 22 appearing that a declaration on behalf of the plaintiff required by Rule 55 has been filed,
 23 setting forth the amounts due plaintiff from said defendant in accordance with the prayer of
 24 the Complaint, and also setting forth that defendant is not an infant or incompetent person
 25 or in the military service of the United States within the meaning of the Service Members
 26 Civil Relief Act [50 U.S.C. Appx. §§ 501 *et. seq.*] (formerly the Soldiers' and Sailor's Civil
 27 Relief Act of 1940), or otherwise entitled to the benefits of said Act, and praying that
 28 Judgment be entered herein.

1 NOW, THEREFORE, by virtue of the law and by reason of the premises aforesaid,
2 IT IS ADJUDGED that the United States of America, plaintiff, do have and recover of
3 and from the defendant, HELI MASHRIQUE aka HELI H. MASHRIQUE, the sum of
4 \$2,677.53 as principal, interest, attorney fees, and costs, plus interest in the amount of
5 \$0.20 per day from August 4, 2015, to the date of entry of the judgment, plus post judgment
6 interest thereafter at the current legal rate per annum, pursuant to the provisions of 28 USC
7 Sec. 1961(a) which will be compounded annually pursuant to the provisions of 28 U.S.C.
8 Sec 1961(b), and judgment is herewith entered accordingly.
