2                   **STIPULATED REQUEST FOR EXPEDITED HEARING RE SETTLEMENT**  
3                   **AGREEMENT**

4           **I. BACKGROUND**

5           In June 2017, the parties to this action globally settled their pending legal disputes,  
6 including this case. A copy of the fully executed Settlement Agreement and Release (Agreement)  
7 was provided to the Court at the last case management conference (CMC), as Exhibit A to the  
8 CMC statement. Pursuant to the Agreement, the Court dismissed this case, and ordered the  
9 parties to post-settlement mediation to try to resolve ongoing disagreements about the enforceable  
10 terms and conditions of the Agreement.

11           The California Department of Corrections and Rehabilitation (CDCR) and Dr. Chris  
12 Wadsworth attended mediation on December 4, 2017.

13           The CDCR and Dr. Wadsworth disagreed about whether the Agreement requires Dr.  
14 Wadsworth to transfer from San Quentin State Prison (San Quentin) to Folsom State Prison  
15 (Folsom), effective January 1, 2018, and they were unable to resolve this issue at the mediation  
16 on December 4, 2017. At the mediation, the CDCR and Dr. Wadsworth stipulated to an  
17 expedited hearing and simultaneous briefing schedule, and agreed to jointly request an expedited  
18 hearing on the transfer issue prior to the effective date of the transfer.

19           The other defendants are not involved in the transfer dispute, and have agreed to postpone  
20 their involvement in the ongoing post-settlement mediation until after the transfer dispute is  
21 resolved. Dkt. 70-71.

22           **II. STIPULATED HEARING REQUEST**

23           The CDCR defendants and Dr. Wadsworth stipulate to, and request, the following  
24 expedited hearing and briefing schedule:

25           1.    The Court will have an expedited hearing at 1:30 p.m. on December 21, 2017 to  
26 determine whether, pursuant to the settlement agreement, Dr. Wadsworth is required to transfer  
27 from San Quentin to Folsom, effective January 1, 2018.

28           2.    The CDCR and Dr. Wadsworth will file their respective moving briefs regarding the  
transfer to Folsom on December 12, 2017.

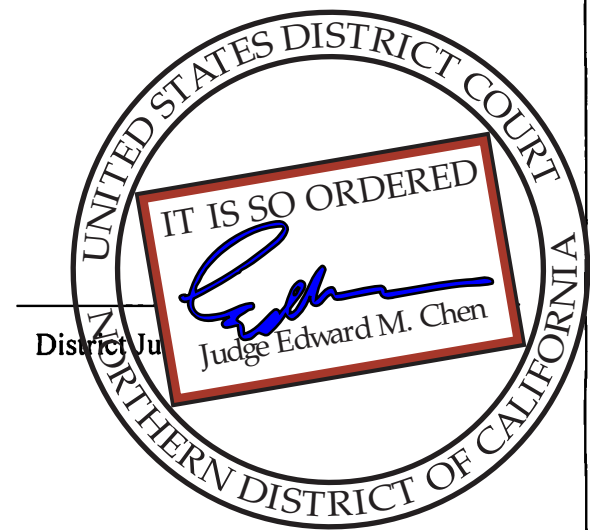
