2 WHEREAS, plaintiff United Energy Trading, LLC (“UET”) filed this action on May 28,
3 2015;

4 WHEREAS, on May 13, 2016, UET filed its Second Amended Complaint;

5 WHEREAS, on August 25, 2016, defendants Pacific Gas and Electric Company
6 (“PG&E”), Albert Torres, William Chen, and Tanisha Robinson (collectively, the “Individual
7 Defendants,” and together with PG&E, the “defendants”) filed an Answer to UET’s Second
8 Amended Complaint;

9 WHEREAS, the parties agreed to and the Court approved a discovery plan, which the Court
10 has previously modified upon the parties’ stipulated requests, most recently on June 26, 2017 (Dkt.
11 161);

12 WHEREAS, the deadline for the parties to supplement expert reports in accordance with
13 Federal Rule of Civil Procedure 26(a)(2) is August 18, 2017;

14 WHEREAS, PG&E produced additional data on July 28, 2017, necessary for UET’s expert
15 witness Gregory S. Thaler to complete his damages analysis through to June 30, 2017, and Mr.
16 Thaler needs additional time to analyze the data and supplement his report;

17 WHEREAS, all parties have agreed that UET should have until September 8, 2017 for Mr.
18 Thaler to supplement his expert report based on the additional data produced on July 28, 2017, in
19 accordance with Federal Rule of Civil Procedure 26(a)(2);

20 WHEREAS, good cause exists for extending the time for Mr. Thaler to supplement his
21 expert report based on PG&E’s recent data production;

22 WHEREAS, the stipulated extension of the deadline to supplement UET’s expert report
23 will not affect any other deadlines in the case;

24 WHEREAS, extending the deadline for Mr. Thaler to supplement his expert report based
25 on the data produced on July 28, 2017 will not prejudice the parties or the Court;
