



1                   **[PROPOSED] ORDER GRANTING STIPULATED REQUEST TO EXTEND**  
2                   **DEADLINE TO FILE REPLY BRIEFS IN SUPPORT OF MOTIONS FOR PARTIAL**  
3                   **SUMMARY JUDGMENT**

4                   WHEREAS, plaintiff United Energy Trading, LLC (“UET”) filed this action on May 28,  
5                   2015;

6                   WHEREAS, on May 13, 2016, UET filed its Second Amended Complaint;

7                   WHEREAS, on August 25, 2016, defendants Pacific Gas and Electric Company  
8                   (“PG&E”), Albert Torres, William Chen, and Tanisha Robinson (collectively, the “Individual  
9                   Defendants,” and together with PG&E, the “defendants”) filed an Answer to UET’s Second  
10                  Amended Complaint;

11                  WHEREAS, the parties agreed to and the Court approved a case schedule, which the  
12                  Court has previously modified upon the parties’ stipulated requests, most recently on September  
13                  22, 2017 (Dkt. #174);

14                  WHEREAS, the Court’s approved schedule set December 8, 2017 as the last day to hear  
15                  dispositive motions (Dkt. #174);

16                  WHEREAS, UET and defendants filed motions for partial summary judgment on  
17                  November 3, 2017, which are set for hearing on December 8, 2017 (Dkt. ##190, 194);

18                  WHEREAS, pursuant to Civil Local Rules 7-3(a) and 7-3(c), oppositions to the parties’  
19                  motions for partial summary judgment are due on November 17, 2017 and replies in support of  
20                  the parties’ motions for partial summary judgment are due on November 24, 2017;

21                  WHEREAS, the deadline to file replies in support of the parties’ motions for partial  
22                  summary judgment is the day after the November 23, 2017 Thanksgiving holiday;

23                  WHEREAS, to ease the burden on and avoid affecting the Thanksgiving plans of the  
24                  parties, their attorneys, and their staff, the parties would like to extend the deadline to submit  
25                  replies in support of motions for partial summary judgment by two business days to November  
26                  28, 2017;

27                  WHEREAS, good cause exists for extending the time to file replies in support of motions  
28                  for partial summary judgment by two business days;
