The parties are ordered to submit supplemental briefs, not to exceed 15 pages, on the following issues:

- 1. With respect to the timeliness of the removal, is there an argument that the 30-day deadline was tolled while the motion to quash was being litigated in San Francisco Superior Court? If so, what authority would support such an argument?
- 2. Also with respect to the motion to remand, is there an argument that this case falls within the domestic relations exception to federal jurisdiction? See, e.g., Ankenbrandt v. Richards, 504 U.S. 689, 703-04 (1992); McLaughlin v. Cotner, 193 F.3d 410, 413 (6th Cir. 1999).
- 3. With respect to the motion to dismiss, is there an argument that this lawsuit is precluded, in whole or in part, by any of the prior litigation? That is, have the claims raised by Soliman in this lawsuit been litigated in a prior proceeding, or could they have been litigated in a prior proceeding? See, e.g., Slater v. Blackwood, 543 P.2d 593, 594 (Cal. 1975).

The plaintiff's supplemental brief is due Monday, August 10, 2015. The defendant's supplemental brief is due Friday, August 14, 2015.
