25 WHEREAS, on August 27, 2015, the Court ordered the Initial Case Management

27 WHEREAS, the August 27, 2015 Order sets November 3, 2015 as the last day to
 28 meet and confer regarding initial disclosures, early settlement, ADR process selection

1 and discovery plan, and the last day to file ADR Certification signed by Parties and Counsel,
2 and the last day to file either a Stipulation to ADR Process of Notice of Need for ADR Phone
3 Conference; sets November 17, 2015 as the last day to file Rule 26(f) Report, complete initial
4 disclosures or state objections in Rule 26(f) Report and file Case Management Statement; and
5 sets November 24, 2015 as the date for the Initial Case Management Conference; and

6 WHEREAS, counsel for Plaintiff Gino Emmerich and newly-associated co-counsel for
7 Defendant City and County of San Francisco have met and conferred on approaches to
8 explore the issues in the case, and the parties have agreed to hold an in-person meeting of the
9 parties and counsel for the purpose of discussing the issues in the case and possible early-
10 resolution approaches in late-November or December of 2015, in San Francisco, subject to
11 scheduling; and

12 WHEREAS, the parties believe it would divert resources to hold a case management
13 conference and to comply with all other related deadlines before the parties' meeting
14 described above.

15 THEREFORE, the parties hereby stipulate and agree, and request that the Court order,
16 that the dates set in the Court's Order, dated August 27, 2015, be continued to new dates, as
17 follows:

- 18 1. Last day to meet and confer regarding initial disclosures, early settlement, ADR
19 process selection, and discovery plan should be extended to January 12, 2016
- 20 2. Last day to file ADR Certification signed by Parties and Counsel should be extended
21 to January 12, 2016
- 22 3. Last day to file either a Stipulation to ADR Process or Notice of Need for ADR Phone
23 Conference should be extended to January 26, 2016.
- 24 4. Last day to file Rule 26(f) Report, complete initial disclosures or state objection in
25 Rule 26(f) Report and file Case Management Statement per Standing Order regarding
26 Contents of Joint Case Management Statement should be extended to January 26,
27 2016.

1 5. Date for Initial Case Management Conference should be extended to February 2, 2016.
