 18 In the above entitled action, the defendant KIM R. YOST aka KIM YOST aka KIM
 19 ROCHELLE YOST aka KIM ROCHELLE YOST SR., aka KIM HAMMOND aka KIM
 20 MARTIN having been duly served with the Summons and a copy of the Complaint in the

3 Judgment be entered herein.

4 NOW, THEREFORE, by virtue of the law and by reason of the premises aforesaid,

5 IT IS ADJUDGED that the United States of America, plaintiff, do have and recover of
6 and from the defendant, KIM R. YOST aka KIM YOST aka KIM ROCHELLE YOST aka KIM
7 ROCHELLE YOST SR., aka KIM HAMMOND aka KIM MARTIN, the sum of \$2,988.59 as
8 principal, interest, attorney fees, and costs, plus interest in the amount of \$0.20 per day
