4 the benefits of said Act, and praying that Judgment be entered herein.

5 NOW, THEREFORE, by virtue of the law and by reason of the premises aforesaid,
6 IT IS ADJUDGED that the United States of America, plaintiff, do have and recover of
7 and from the defendant, MELINDA S. BOYSAL aka MELINDA BOYSAL aka MELINDA
8 SUE BOYSAL aka MELINDA S. BODENHAMER aka MELINDA SUE BODENHAMER aka
9 MELINDA BODENHAMER, the sum of \$13,810.43 as principal, interest, attorney fees, and
10 costs, plus interest in the amount of \$0.79 per day from May 8, 2017, to the date of entry of
11 the judgment, plus post judgment interest thereafter at the current legal rate per annum,
