 18 Plaintiff BREANA JOHNSON ("Plaintiff") and Defendants SEARS HOMETOWN AND
 19 OUTLET STORES, INC., SEARS AUTHORIZED HOMETOWN STORES, LLC, and SEARS
 20 OUTLET STORES, LLC ("Defendants") (collectively "the Parties"), by and through their
 21 attorneys of record, stipulate as follows:

22 WHEREAS Defendants have filed a Motion to Compel Arbitration and Dismiss or Stay
 23 Action;

24 WHEREAS the Parties have agreed that it would be most efficient to resolve the claims
 25 alleged in Plaintiff's First Amended Complaint through binding arbitration, pursuant to the terms
 26 of the Parties' Arbitration Agreement, a copy of which is attached as Exhibit 1;

27 WHEREAS the Parties have agreed that the present action should be stayed pending


1 the outcome of the arbitration;

2 WHEREAS Defendants have agreed to pay the full arbitration fee to be incurred in
3 pursuing these claims by means of arbitration;


4 WHEREAS the Parties have agreed that all of the claims alleged by Plaintiff against
5 Defendants in Plaintiff's First Amended Complaint will be dismissed with prejudice after the
6 arbitration process has been completed.

7 IT IS NOW HEREBY STIPULATED AND AGREED that: The Parties will resolve the
8 claims raised by Plaintiff in the present proceeding by means of binding arbitration, with
9 Defendants to pay the full arbitration fee. The above-captioned action will be stayed pending
10 completion of the arbitration process.


