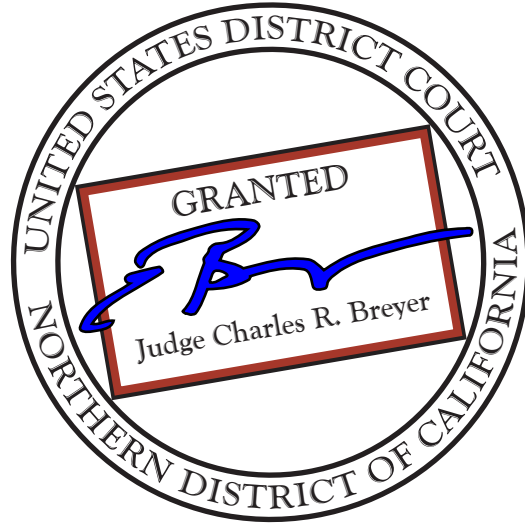
1 Given the pending Motion to Withdraw, we request that the Court vacate the current
