1 **[PROPOSED] ORDER**

2 PURSUANT TO STIPULATION submitted by Plaintiff CITY OF OAKLAND, and

- 5 (1) Defendants may file one or more motions challenging Plaintiff’s First Amended

- 12 (5) As ordered by the Court at the May 25, 2017 Case Management Conference, the Case  
13 Management Conference currently set for November 30, 2017 shall be combined with  
14 the hearing on the Motion(s). An updated joint Case Management Conference shall be  
15 filed no later than 7 days before that hearing.
