6 Corp., Inpaq Technology Company, Hon Hai Precision Industry Co., Ltd., and MediaTek Inc.

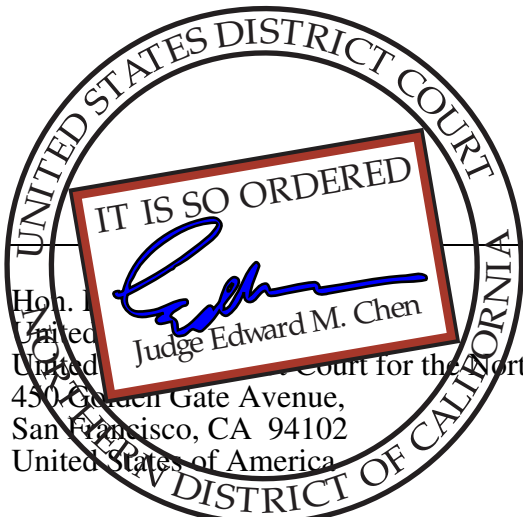
7 Having considered the motion, and any other matters deemed to be appropriate by the Court,
