GOOD CAUSE APPEARING, the Court hereby orders as follows:

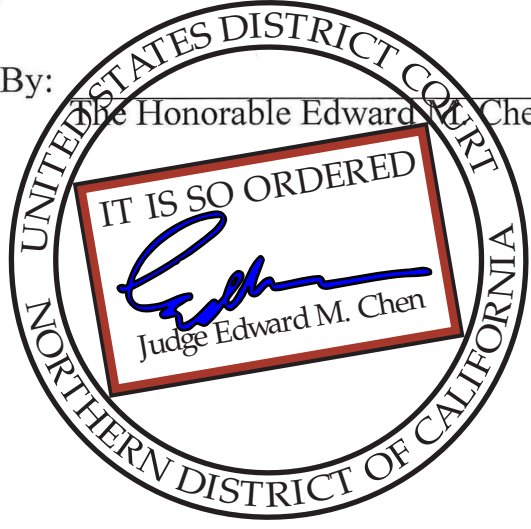
1. The Default requested and entered against Defendant Anason Won Pak on or about January 22, 2016, shall be withdrawn and set aside;


