1 Plaintiff Kaitlyn Shepardson (“Plaintiff”) and Defendant Adecco USA, Inc. (“Adecco” or
2 “Defendant”) (collectively, the “Parties”), through their respective counsel of record, stipulate and
3 agree as follows:

4 WHEREAS, Adecco filed a Motion to Compel Arbitration on February 2, 2016, seeking
5 an order from this Court to compel arbitration of Plaintiff’s individual claims in the above-listed
6 action and to stay litigation pending the completion of arbitration;

7 WHEREAS, a case management conference is scheduled to take place on March 3, 2016;

8 WHEREAS, the Parties’ Joint Case Management Conference Statement and Rule 26(f)
9 report is currently due to be filed by February 25, 2016;

10 WHEREAS, the hearing on Defendant’s Motion to Compel Arbitration is scheduled for
11 March 10, 2016. The Court’s ruling on the motion could impact the Parties’ proposed discovery
12 and scheduling order deadlines in their Rule 26 report since it may result in some or all of the
13 claims being stayed and/or compelled to arbitration;

14 WHEREAS, in order to maximize the efficient use of the Court and Parties’ time, the
15 Parties wish to continue the initial Case Management Conference so that it takes place after the
16 Court issues its order on Defendant’s Motion to Compel Arbitration;

17 **IT IS THEREFORE STIPULATED BY THE PARTIES, THROUGH THEIR**
18 **RESPECTIVE COUNSEL OF RECORD** that, subject to Court approval, the case management
19 conference be continued to a date on or after the Court rules on Defendant’s Motion to Compel
20 Arbitration, at the convenience of the Court.
